## **Correspondence and Announcements:**

Trustee Kellogg-Weaver states from her treasurer report that in the General Fund Account the balance is \$741,441.05.

#### **Report of Library Director:**

Director Flowers states that the Harvey Public Library District will be starting a new program called Bloom which is a program to assist teens in resume building and the retrieval of a High School Diploma or GED. Calvin Fox who is the Founder of the Bloom program was interviewed by NBC where he discussed working with HPLD. There will be a follow up interview to be announced in the near future.

Director Flowers announces that one of Harvey Public Library District's sponsors is taking 50 children to the Auto Show this year.

Director Flowers states that she delegated two HPLD employees to attend the 1<sup>st</sup> Ward Meeting with Alderman Drewenski to represent the Library and to give out program information to the seniors.

Director Flowers states that she delegated two HPLD employees to participate in the Veteran's Day Parade where they carried a banner with trustees' name.

Director Flowers announces that Jerelene Harris will be registering Harvey residents to vote at HPLD on November 10,12,17,19, 24 and 26 from 10am-3pm.

Director Flowers states that the Halloween Fest was a success where they had over one hundred children to attend.

She also announces that the carpet was cleaned throughout the entire building and a new tutor for Adults/Children was hired.

She closes her report stating that vacation list was placed in the Board Packets and the Annual Receipts and Disbursements will be presented at the next Board meeting in December.
